This order is issued to establish the area coverage for Fire Suppression and EMS/Rescue Bureau's emergency responding units.

This Order shall be the standing Order for area coverage and shall rescind all previous orders regarding unit jurisdictions.

**AREA OF COVERAGE/JURISDICTION
 FIRE SUPPRESSION**

NORTHERN FIRE FIGHTING DISTRICT

TAMUNING FIRE STATION - Engine #1.

Covers: East Agana, Tamuning, Tumon, Upper Tumon and areas of Harmon Industrial Park.

Tamuning north of Rt. #14 from the intersection of Rt. #14 and Rt. #1 (ITC Intersection), Tumon, Upper Tumon, to Rt. #14 and Rt. #1 (near Australian Cable and Horizon Hotel); West sectors of Harmon Industrial Park from GWA after storage tank to Harmon Cold Storage; West on Rt. #10A from the intersection of Rt. #10A and Rt. #16 to Rt. #10A and Rt. #1; **Assisted by Engine #4.**

Areas west of Rt. #14 from the intersection of Rt. #14 and Rt. #1 (ITC Intersection) to the intersection of Rt. #1 and Rt. #8, East Agana; Areas north of Rt. #8 from the intersection of Rt. #7A and Rt. #8 to the intersection of Rt. #1 and Rt. #8, including Plumeria Garden Hotel and Franquez Rd. areas; **Assisted by Engine #2.**

SINAJANA FIRE STATION - Engine #2.

Covers: Sinajana, Agana Heights, Agana, Anigua, Lower Maina, Ordot, and Chalan Pago. All surrounding areas of Rt. #1 from the junction of Rt. #1 and Fonte Bridge, Anigua to the intersection of Rt. #1 and Rt. #8, East Agana; All Agana areas within the boundaries west and north of Rt. #7A (West and East O'Brien Drive) to Rt. #1, including Nieves M. Flores Memorial Library, Agana Swimming Pool; Areas west and south of Rt. #8 from the intersection of Rt. #7A and Rt. #8 to the intersection of Rt. #1 and Rt. #8; **Assisted by Engine #1.**

From the intersection of Rt. #6 and Maria Candelaria Rd., Lower Maina to the intersection of Fonte Rd. and Maria Candelaria Rd., Agana Heights; Areas within the boundaries of Rt. #7 from the intersection of Rt. #6 and Rt. #7 to Luna Ave. and Rt. #7, Agana Heights, including areas west of Luna Ave.; **Assisted by Engine #7.**

Route #4 from the intersection of Rt. #4 and Chalan Canton Tutujan, Sinajana (near gas station), Agana Springs, Didigue, areas south of East O'Brien Dr. from the intersection of Chalan Obispo and East O'Brien Dr. to the junction of Agana River Bridge, including Guam Mass Transit, Agana Shopping Centers, and those surrounding; Sinajana, from the intersection of Fonte Rd. and Maria Candelaria Rd., Agana Heights, eastern areas of Luna Ave., east on Rt. #7 from the intersection Rt. #7 and Luna Ave. to the intersection of West O'Brien Dr. and Chalan Obispo, including the Superior Court Building; **Assisted by Engine #3.**

Route #4 from the intersection of Rt. #4 and Chalan Canton Tutujan, Sinajana (near gas station), including Afame, Ordot, and Chalan Pago to the intersection of Rt. #4 and Rt. #10; Dero Drive and Access Road, Ordot from the Lonfit River Bridge to Rt. #4; Maimai St. from the intersection of Salas St. and Maimai St. to the intersection of Rt. #4 and Maimai St.; **Assisted by Engine #9.**

Barrigada Fire Station - Engine #3.

Covers: Barrigada, Mangilao, Mongmong, Toto, Maite, Tiyan East on Route #8 from the intersection of Rt. #8 and Rt. #7A; East of Rt. #7A from Agana River Bridge, including Tenbat St. areas and all surrounding areas eastbound on Rt. #33, Sgt. Roy T. Damian St. and Rt. #8 to the intersection of Rt. #8 and Rt. #10, including Mongmong, Toto, Maite, and Barrigada; Tiyan to the northern entrance gate (airport terminal side), Barrigada (Canada & Leyang); Areas of Maimai St., Mangilao from the intersection of Salas St. and Maimai St., Dairy Rd., to the intersection of Rt. #10 and Dairy Rd., Mangilao (near Price Elementary School); Areas of Route #10 from the intersection of Rt. #10 and Rt. #15 (Price Elementary School) to the intersection of Rt. #10 and Rt. #8; **Assisted by Engine #2.**

Route #15 from the intersection of Rt. #15 and Rt. #10 northbound to Rivera St., Pagat; East on Route #8 from the intersection of Rt. #8 and Rt. #10, including Radio Barrigada and Admiral Nimitz Golf Course areas; Surrounding areas of Route #16 from the intersection of Rt. #16 and Rt. #8 to the intersection of Rt. #10A and Rt. #16; Bello St. from the intersection of Rt. #16 and Bello St. to the junction of Bello St. and Alageta St.; **Assisted by Engine #4.**

Surrounding areas of Route #10 from the intersection of Rt. #10 and Rt. #4 to the intersection of Rt. #10 and Rt. #15; **Assisted by Engine #9.**

Dededo Fire Station - Engine #4

Covers: Areas of Upper Tumon, Harmon, Dededo Village proximity including Ukudu, Upper and Lower Kaiser, GHURA 501, Ligan Terrace, Harmon CT Subdivision Harmon Garden Subdivision, South Acres, Macheche, Macheche subdivision, Mogfog, and Latte Heights areas.

All areas of Rt. #1 from the Intersection of Rt. #1 and Rt. #14 (Australian Cable), including Australian Cable and Horizon Hotel, to Rt. #16 and Rt. #1, including Two Lovers Point and sectors west of Two Lovers Point Road, Rt. #34; East sectors of Harmon Industrial Park and Harmon Cold Storage to Route #16; **Assisted by Engine #1.**

Areas within the boundaries north of Route #27A (Fatima St. and Santa Monica Ave.) from the intersection of Rt. #16 and Rt. #27A Fatima St. and the intersection of Rt. #27A, Santa Monica Ave. and Rt. #28, Y-Sengsong Rd. (including parts of Rt. #16, Rt. #1, Rt. #3, the Micronesia Mall, Harmon Doctor's Clinic, and GHURA 48), to areas south of Swamp Rd., Stampa Rd., and Royal Palm housing (Rt. #3 federal housing); Areas within the boundaries east of Two Lovers Point and Two Lovers Point Rd., Rt. #34, to Rt. #3 surrounding areas south of Royal Palm housing (including U.S. Federal Gov't Corral area and North Ukudu); **Assisted by Engine #12.**

Areas within the boundaries east of Rt. #16 from the intersection of Rt. #16 and Rt. #27A Fatima St. to the intersection of Rt. #16 and Bello St.; all areas south of Rt. #27A (Fatima St., West and East Santa Monica Avenue); Areas of Rt. #26, Carnation Ave.; Areas of Route #15 from Rivera St., Pagat to the intersection of Rt. #15 and Rissi Rd, Wilson Homes (Andy South); Areas of Rt. #1 west of Ypaopao Estates; Areas south on Bartulo St. from and including GHURA 501; **Assisted by Engine #10.**

YIGO FIRE STATION - Engine #10

Covers: Ypaopao Estates, Wusstig Rd., GHURA 505, Perez Acres, GHURA 505 and 506, Nishio Subdivision, Ponderosa Gardens, Bordallo Subdivision, Salas Subdivision, Mataguac Estates, Chaguian, Machananao Ypaopao Estates, Marianas Terrace, Takano Subdivision, Gayinero, Mount Santa Rosa, and Lupog.

Surrounding areas on Rt. #15 from Rt. #15, Mount Santa Rosa to and including Rissi Rd., Wilson Homes; Areas of Rt. #1 southbound from Anderson Air Force Base gate to and including Ypaopao Estates; Areas east of the intersection of Chalan Cabesa, Chalan Mataguac and Chalan Aniles, Yigo including Q's Ranch, Chalan Arendo, and Chalan Maanao; **Assisted by Engine #4.**

Areas east of an imaginary line running southwest and northeast from the intersection of Chalan Cabesa, Chalan Mataguac and Chalan Aniles, through the intersection of Rt. #9 and Chalan Emsley to Rt. #1 Anderson Air Force Base gate, including Chalan Tupu; **Assisted by Engine #12.**

ASTUMBO FIRE STATION - Engine #12

Coverage: Astumbo, Astumbo Gardens, Y-Sengsong, Machanao Subdivision, Finegayan, Fern Terrace, Perez Garden Subdivision, Santa Ana Subdivision, Machananao Subdivision, and Agafa-Gumas (Machanao).

Areas north of Rt. #3 and Rt. #28 from Two Lovers Point, Royal Palm housing, Swamp Rd., and Stampa Rd. to the junction of Rt. #3 and Rt. #9, Potts Junction, including Santa Ana Subdivision, Machananao Subdivision, Machanao Subdivision, Y-Sengsong, Perez Garden Subdivision, and Fern Terrace; Areas within the boundaries west of an imaginary line running north and south through the intersection of Chalan Cabesa, Chalan Mataguac, and Chalan Aniles through the intersection of Rt. #3 and Rt. #9, Potts Junction, including areas of Chalan Koda, Chalan Ibang, East Flores Cadena, and Chalan Palauan; **Assisted by Engine #4.**

Areas of Rt. #9 from the intersection of Rt. #9 and Chalan Emsley to the junction of Rt. #9 and Rt. #3 (Potts Junction), excluding Santa Ana Subdivision and Machananao Subdivision; Areas east of an imaginary line running north and south from the intersection of Chalan Cabesa, Chalan Mataguac, and Chalan Aniles through the junction of Rt. #3 and Rt. #9 (Potts Junction) to areas west of an imaginary line running southwest and northeast from the intersection of Chalan Cabesa, Chalan Mataguac, and Chalan Aniles through the intersection of Rt. #9 and Chalan Emsley, including areas of Chaguian Chalan Machananao Rd.; **Assisted by Engine #10.**

SOUTHERN FIRE FIGHTING DISTRICT

AGAT FIRE STATION - Engine #5

Covers: Agat, Santa Rita, Apra Heights, Talisay, Rt. #17 Upper Talisay

Route #2 and Rt. #2A from Rt. #2, Pagachao Subdivision to the intersection of Rt. #1 and Rt. #2A; Route #12, Santa Rita and Rt. #5, Agat areas; **Assisted by Engine #7.**

Route #2 from Rt. #2, south of Pagachao Subdivision, including Nimitz Beach to Mt. Lamlam Overlook; **Assisted by Engine #8.**

Areas of Rt. #17 from the intersection of Rt. #5 and Rt. #17, Upper Talisay to the intersection of Rt. #17 and Disconsagon Dr. (Chapel area), Apra Heights; **Assisted by Engine #11.**

INARAJAN FIRE STATION - Engine #6

Covers: Inarajan, Malojloj villages, and Talofobo Bay.

Route #4 from the intersection of Rt. #4 and Rt. #4A through Malojloj to Belen Avenue and Chagamin Ave., Inarajan (Inarajan Middle School Rd.); **Assisted by Engine #11.**

Areas of Rt. #4 from Belen Avenue and Chagamin Ave., Inarajan (Inarajan Middle School Rd.) to Ajayan River Bridge (near Inarajan Aqua culture); **Assisted by Engine #8.**

PITI FIRE STATION - Engine #7

Covers: Asan, Piti, Nimitz Hill, Ship Repair Facility (SRF) Compound

Areas of Rt. #1 from Piti Village past the intersection of Rt. #2A and Rt. #1 to and including SRF Compound; West on Rt. #6 from Rt. #6 and Asan Bay Overlook; **Assisted by Engine #5.**

Areas of Rt. #1 east of Piti Village, including Asan Village to Fonte Bridge (by One-Stop Center), Adelup; Route #6, upper Maina, Nimitz Hill to east of Rt. #6 and Asan Bay Overlook; **Assisted by Engine #2.**

UMATAC FIRE STATION - Engine #8

Covers: Umatac and Merizo Villages.

Areas of Rt. #4 from Ajayan River Bridge (near Inarajan Aqua Culture) to Toguan River Bridge (by GWA Treatment Plant at the border of Merizo and Umatac), including Quinene Road, Espinosa Avenue, and Pigua Subdivision: **Assisted by Engine #6.**

Areas of Rt. #4 from Rt. #4 and Toguan River Bridge (by GWA Treatment Plant at the border of Merizo and Umatac), through Umatac Village to Mt. Lamlam Overlook; **Assisted by Engine #5.**

YONA FIRE STATION - Engine #9

Covers: Yona Village, Pago Bay, Manengon Hills (Leo Palace Resort). Areas of Rt. #4 from Rt. #4 and Pago Bay Overlook (Bordallo Overlook) to the intersection of Rt. #4 and Rt. #17, including Yona Village, As Namu, Pulantat, Camp Witek, Manengon Valley, and Ylig areas; Areas east of the junction of Leo Palace Resort entrance and Access Road towards the village of Yona; **Assisted by Engine #11.**

Areas of Rt. #4 from the intersection of Rt. #4 and Rt. #10, including Inalado Rd., Chalan Ping Pago (by Judge Manibusan residence) to Rt. #4 and Pago Bay Overlook (Bordallo Overlook); Areas of Access Rd. from the Leo Palace Resort to Lonfit River Bridge, Ordot; **Assisted by Engine #2.**

TALOFOFO FIRE STATION - Engine #11

Covers: Talofofu Village, Ipan, Windward Hills, and Baza Gardens. Areas of Rt. #4A from GPA substation along Rt. #4A, Talofofu village to the intersection of Rt. #4 and Rt. #4A; **Assisted by Engine #6.**

Areas of Rt. #17 from west of the intersection of Rt. #17 and Fairway Dr. (entrance to Takayama Golf Course near Ysrael Apartments, Windward Hills), including Our Lady of Peace Memorial Cemetery area, to the intersection of Rt. #17 and Disconsagon Dr. (Chapel area), Apra Heights; **Assisted by Engine #5.**

Areas of Rt. #4 from the intersection of Rt. #4 and Rt. #4A through Ipan to the intersection of Rt. #4 and Rt. #17; Route #4A west of the GPA substation along Rt. #4A, Talofof village to the intersection of Rt. #4A and Rt. #17, including Talofof Golf Course; Route #17 from the intersection of Rt. #17 and Fairway Dr. (including Takayama Golf Course and Ysrael Apartments, Windward Hills) to the intersection of Rt. #17 and Rt. #4, including Baza Gardens and Windward Hills; **Assisted by Engine #9.**

TANKER AREA OF COVERAGE/JURISDICTION

TANKER #10 - Yigo Fire Station

Covers: East Agana, Tamuning, Tumon, Harmon, Dededo, Astumbo, Yigo, Mongmong, Toto, Maite, Barrigada, and Mangilao.

All areas north and northeast of Rt. #4 from the intersection of Rt. #1 and Rt. #4 and the intersection of Rt. #4 and Rt. #10.

TANKER #9 - Yona Fire Station

Covers: Agana, Asan, Piti, Nimitz Hill, Agana Heights, Sinajana, Ordot, Chalan Pago, Yona, Talofof, Malojloj, and Apra Heights.

All central island areas south and southwest of Rt. #4 from the intersection of Rt. #1 and Rt. #4 to the intersection of Rt. #4 and Rt. #10; Areas of Rt. #4 from the junction of Rt. #4 and Rt. #10 to the junction of Rt. #4 and Pauliloc Bridge, Inarajan; Areas of Rt. #1 from the intersection of Rt. #1 and Rt. #4, including Agana, Asan, Nimitz Hill, and Piti, to SRF Compound; Route #2A from the intersection of Rt. #2A and Rt. #1 through the junction of Rt. #2A and Rt. #5, Rt. #5 into and all areas of Rt. #17.

TANKER #8 - Umatac Fire Station

Covers: Santa Rita, Agat, Umatac, Merizo, and Inarajan.

All southern island areas south and southwest of Rt. #5 and south on Rt. #4 from the junction of Rt. #4 and Pauliloc Bridge, Inarajan.

CASCADE, CHEMICAL, HIGH-RISE APPARATUS AREA OF COVERAGE/JURISDICTION

Tamuning Fire Station

Units shall respond to all major structure fires including: warehouses, hotels, department stores, or multiple story structures upon the direction of the Incident Commander.

AREA OF COVERAGE/JURISDICTION EMS RESCUE

RESCUE #1-TIYAN (Land Unit)

Jurisdiction/Area of Coverage includes all villages, municipality and areas within the borders indicated below:

Village coverage include: Piti, Anigua, Adelup, Asan, Maina, Nimitz Hill, Agana, Agana Heights, Sinajna, Chalan Pago, Ordot, Barrigada, Mongmong-Toto-Maite, Tiyan, Harmon, Tamuning, Tumon, Upper Tumon, Parts of Dededo & Yigo)

All areas between the intersection of Rt#1 & Rt#11 (former USO) to Rt#1 & Rt#3 intersection (Wettengel Junction) and all eastern portions of Rt#1 from Wettengel Junction (Rt#1 & Rt#3 intersection) towards AAFB front gate. All areas within intersection of Rt#1 & Rt#11 (USO) across island to Pago Bay north towards Rt#15 AAFB back gate.

RESCUE #2-SINAJANA (Sea Unit)

All areas from Glass Breakwater, Apra Harbor northbound to Pati Point, around the northern tip of the island to Pago Bay. All areas within the above mentioned up to approximately 10 miles off-shore.

RESCUE #3-AGAT MARINA (Land and Sea Unit)

Land Coverage: All areas from the intersection of Rt#1 & Rt#11 (former USO) southbound towards boundary of Merizo/Inarajan.

Village Coverage: Agat, Santa Rita, Apra Heights, Umatac, Merizo and parts of Piti

Sea/Ocean Coverage: Inside Apra Harbor, from Glass Breakwater southbound to Cocos Island, around the southern tip of island and northbound towards Pago Bay. All areas within the above mentioned up to approximately 10 miles off-shore.

RESCUE #4-TALOFOFO (Land Unit with SCUBA Dive Capable)

Village Coverage includes: Talofof, Inarajan, Malojloj, Yona, Windward Hills and part of Apra Heights.

All areas within Inarajan/Merizo boundary northbound to Pago Bay and extending across Windward Hills and ending at the intersection of Rt#17 & Rt#5, Apra Heights.

RESCUE #5-ASTUMBO (Land with SCUBA Dive Capable)

Village Coverage: Portions of Dededo & Yigo, NCS, Finegayan, Astumbo & Santa Ana.

All areas on the west side of Rt#1 from Wettengel Junction (Rt#1 & Rt#3 intersection) northbound to AAFB front gate including all of Rt#3 and Rt#9.

AREA OF COVERAGE/JURISDICTION EMS AMBULANCE

NORTHERN (EMS)

TAMUNING FIRE STATION/Medic #1

Coverage includes all villages, municipality and areas within the borders indicated below: (Tamuning, Tumon, Ypao, Agana, Agana Heights, Adelup, Anigua, Asan, Maina, Nimitz Hill, and parts of Sinajana, Piti, Upper Tumon, Harmon, and Tiyan)

Northern Border: Rt#1 & Happy Landing Road (Old San Vitores Rd) and Won Pat International Airport to end of terminal, Harmon Industrial Park to Cold Storage facility (by entrance to flea market), all of San Vitores Road.

Southern Border: Rt#1 & Rt#6 (by Veteran's Cemetery, Piti).

Eastern Border: Rt#1 & Rt#8 through Rt#4 Sinajana (by Ada's Funeral Home).

BARRIGADA FIRE STATION-Medic #3

Coverage includes all villages, municipality and areas with the borders indicated below: (Barrigada, Radio Barrigada, Mangilao, parts of Pagat, Mongmong-Toto-Maite, Tiyan and parts of Agana)

Northern Border: Rt#15 to Kinney's Cafe', Rt#10 to Father Duenas Memorial School, to Rt#16 & Rt#10A and Upper Bello Road.

Southern Border: Rt#1 & Rt#8, East O'Brien Drive to Rt#4, Agana (by Sizzler's), and all areas within Tiyan.

Advance Life Support (ALS-1)

Primary mission is to respond as an intercept unit for all medical emergencies requiring advanced life support systems. Area of coverage includes the entire island of Guam.

DEDEDO FIRE STATION-Medic #4

Coverage includes all villages, municipality and areas within the borders indicated below. (Dededo, Harmon, Kaiser, Liguán Terrace, Harmon Loop, Macheche, Latte Heights, Latte Plantation & Adacao, parts of Pagat)

Northern Border: Rt#1 to areas south of Aga Blvd, Rt#28 (Ysengsong Rd) & Bartulu St., Upper Kaiser and West Binadu St.

Eastern Border: Rt#15 from Kinney's Cafe to GPA Substation, Rt#16 and Rt#10A to north end of terminal (Won Pat International Airport).

Southern Border: Rt#1 to Happy Landing Road (Old San Vitores Rd.), all areas of Sanchez St. (by Chief Brodie Elem. School), Harmon Flea Market, Two Lovers Point and Tanguisson Beach.

NOTE: Medic #4 is equipped to respond as Advance Life Support (ALS) unit (when manpower permits) and shall be utilized as intercept unit for Medic#10 and Medic#12.

YIGO FIRE STATION-Medic #10

Coverage includes all villages, municipality and areas within the borders indicted below: (Yigo, Ypaopao Estate, Wusstig Rd, Bordallo, Takano & Salas Subdivisions, Mt. Santa Rosa, Gayinero, Marianas Terrace & Andy South)

Northern border: Rt#1 to Rt#9 (by entrance to AAFB front gate), areas south of Chalan Mataguac and south of Evangelista Rd.

Southern Border: Rt#1 & areas north of Aga Blvd., Ypaopao Estates, Wusstig Rd & Chalan Sanhalum and Rt#15 areas north of GPA Substation to back gate of AAFB.

ASTUMBO FIRE STATION-Medic #12

Coverage includes all villages, municipality and areas within the borders indicated below: (Astumbo, Finegayan, Ukudu, Machanaonao, Santa Ana, parts of Ysengsong & Mataguac)

Northern Border: Rt#9 by AAFB front gate, areas north of Chalan Mataguac to Evangelista Rd., Mataguac Estates, Upper Wusstig Rd. to Chalan Sanhanum.

Southern Border: Rt#28 (Ysengsong Rd) to Bartulu St., Ukudu and intersection of Rt#1 & Rt#3.

SOUTHERN

AGAT FIRE STATION-Medic #5

Coverage includes all villages, municipality and areas with the borders indicated below. (Agat, Santa Rita, Sumay, Apra Heights, parts of Piti)

Northern Border: Rt#1 & Rt#6 by Veteran's Cemetery and Rt#17 to Guam Raceway Park, Apra Heights.

Southern Border: Rt#2 by Cetti Bay Overlook.

INARAJAN FIRE STATION-Medic#6

Coverage include all villages, municipality and areas within the borders indicated below.
(Inarajan, Malojloj, NASA and parts of Talofoyo)

Northern Border: Rt#4 Asalonso Bridge and southbound.

Southern Border: Rt#4 Ajayan Bridge and northbound.

UMATAC FIRE STATION-Medic#8

Coverage includes all villages, municipality and areas within the borders indicated below.
(Umatac, Merizo & Cocos Island)

Northern Border: Rt#2 by Cetti Bay Overlook.

Eastern Border: Rt#4 from areas south of Ajayan Bridge.

YONA FIRE STATION-Medic#9

Coverage includes all villages, municipality and areas within the borders indicated below.
(Yona, Chalan Pago, Ordoy and parts of Sinajana)

Northern Border: Rt#4 Chaot Bridge below Ada's Funeral Home, Sinajana and all areas within Ordoy, Chalan Pago (including Maimai & Conga Rd) and Pago Bay (Inalado Rd.).

Southern Border: Intersection of Rt#4 & Rt#17 northbound including Manengon, Camp Witek, Pulantat, LeoPalace Resort & As Namoy areas.

NOTE: Medic#9 is equipped to respond as Advance Life Support (ALS) unit (when manpower permits) and shall be utilized as intercept unit for all Basic Life Support (BLS)units assigned to southern district.

TALOFOFO FIRE STATION-Medic #11

Coverage includes all villages, municipality and areas within the borders indicated below:

Western Border: Rt#17 north of Guam Raceway Park, Apra Heights towards Windward Hills area.
